### Company profile

广东广物国际能源集团有限公司(以下简称广物能源)是由原广东广物国际贸易有限公司与原广东广物能源化工集团有限公司、原广东省民用爆破器材有限公司,于2018年10月根据广东省广物控股集团有限公司(国家重点培育的20家流通领域大企业集团之一,以下简称广物控股集团)的决定实施战略性重组而成立的,是广物控股集团所属骨干二级子集团,同时管理着广物控股集团境外平台——广东广物香港有限公司(以下简称香港公司),所属有广东省燃料有限公司、青岛广物国际贸易有限公司、广东省化工轻工有限公司、广东物通实业投资有限公司、广东省林产工业有限公司等全资子公司及1家控股子公司广东广物能源科技有限公司,聚焦于石油及制品、天然气、橡胶、矿产品、煤炭、焦炭、农产品等以能源化工产品为主的大宗商品产业化经营,是华南地区生产资料流通行业发展历史长、经营规模大、服务功能齐、在业界具有较高知名度的企业。

(one of the top 20 circulation enterprises in China directly supported by the country, hereinafter referred to as GW Holdings Group) in October 2018. GW Energy is the major subsidiary enterprise of the GW Holdings Group. It simultaneously manages the overseas platform of GW Holdings Group—Guangdong GW (Hongkong) Co., Ltd. (hereinafter referred to as GW Hongkong). GW Energy's wholly-owned subordinate enterprises include: Guangdong Fuel Co., Ltd., Qingdao Guangwu International Trade Co., Ltd., Guangdong Chemical Light Industry Co., Ltd., Guangdong Wutong Industrial Investment Co., Ltd., Guangdong Forest Products Industry Co., Ltd., and a holding subsidiary, Guangdong Guangwu Energy Technology Co., Ltd. Focusing on the industrialized operation of bulk commodities with energy and chemical products as the mainstay, such as petroleum and its product, natural gas, rubber, mineral products, coal, and agricultural products, GW Energy is an enterprise with a long history of development, a large scale of operation, complete service functions, and a high reputation in the industry for the circulation of production materials in South China.

In the future, GW Energy will resolutely implement the new concept of state-owned enterprise development in the new era, give full play to the advantages of resource integration of overseas and domestic dual platforms, grasp the new development pattern which domestic economic cycle plays a leading role while international economic cycle its extension and supplement, and seize the development opportunities in the Guangdong-Hong Kong-Macao Greater Bay Area. 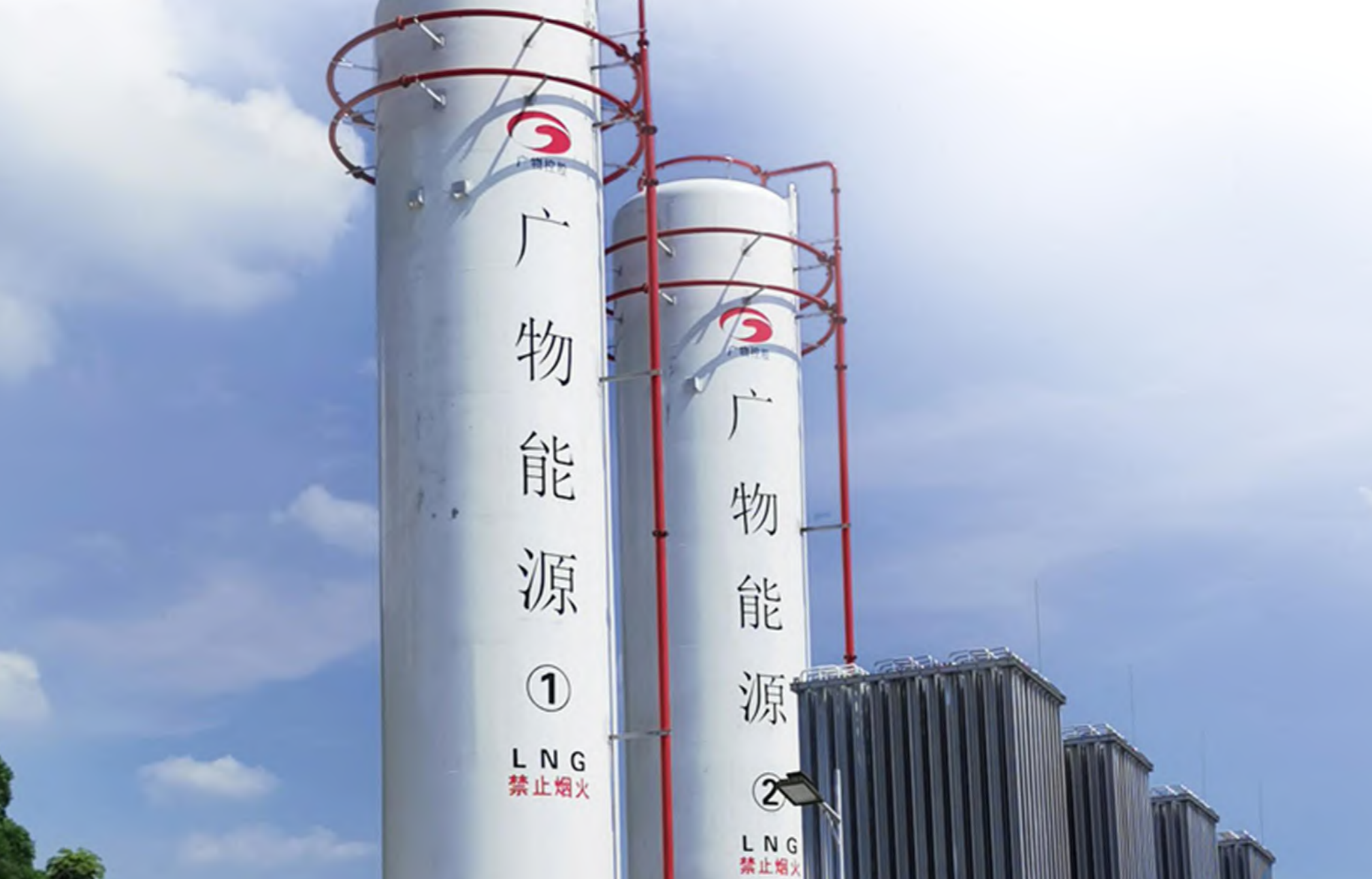
